Any dog of any ancestry may be registered in the Obedience & Working Trials Register. A dog so registered may be eligible to compete in Obedience, Working Trials, Agility, Heelwork To Music and Flyball competitions only. It is not eligible to compete in Breed Competitions, Field Trials or Gundog Working Tests.

Progeny of dogs so registered will only be eligible for registration in the Obedience & Working Trials Register. Unless either the breeders declaration is signed by the breeder or the application is accompanied by a signed pedigree, the parentage and date of birth should be entered as "unknown".

## **Please read these notes before completing the form**

### NON ACCEPTANCE OF REGISTRATION

The General Committee may reject any application to register an affix or to register or transfer any dog or to change or cancel a name and may cancel or suspend any registration or transfer or grant of an affix already made. The acceptance of a registration is not a guarantee of its accuracy.

The declaration must be signed by all the owners in the case of joint ownership.

When at the date of closing of entries for a show, an exhibitor has applied for, but has not received the registration certificate, the dog shall be entered in the name shown as first choice on this form, followed by the letters NAF (name applied for).

### NAMING OF DOGS

When choosing the name of a dog, please bear in mind :-

- a) Proposed names must not exceed 24 letters including the affix
- b) If you are the grantee of a registered affix and wish to use it when registering dogs, the affix must appear as the first word in the name if the dog was either bred by you, or was bred from parents each of which was bred by you.
- c) If you are not the holder of a registered affix:-
  - i) do not use words from the dog's pedigree since they may be affixes held by another person and your proposed names will not then be acceptable.
  - ii) do not repeat a word when naming dogs unless you are applying, or have applied, for this word to be registered as an affix
  - iii) if you are submitting with this form an application to register an affix, it will be necessary for the registration of the affix to be dealt with first before the dog's registration certificate is issued. This process can take up to a month to complete.
- d) Names of notable persons, countries, cities, numerals and common single words are not acceptable. Also do not use single letters as part of a name, nor initials or your own surname.

### ENDORSEMENTS

The registered owner of a dog may, whilst the dog is still in his physical possession, apply to have either of the following endorsements placed on the records of the dog and to have the relevant Registration and / or transfer certificate marked accordingly

R - Progeny Not Eligible for Registration

X - Not eligible for the issue of an Export Pedigree

Should the owner wish any of these endorsements to be made in respect of the dog now being registered, this should be requested in a separate letter attached to the form. Any endorsement shall only be lifted either at the written request of the endorsee, or by the General Committee.
