**GENERAL**

**NON-ACCEPTANCE OF REGISTRATION**

The General Committee may reject any application to register an affix, or register or transfer any dog, or to change or cancel a name and may cancel or suspend any registration or transfer or grant of an affix already made. The acceptance of a registration is not a guarantee of its accuracy. The breeder of a dog is the owner of the dam at the time of whelping, unless a registration has been affected under the Regulations for Loan of a Bitch for breeding purposes. The breeders declaration need not be signed in cases where the dog is already registered with the ISDS (in the ownership of the applicant(s)). The declaration must be signed by all owners in the case of a joint ownership. When at the date of closing of entries for a show, an exhibitor has applied for, but has not received, the certificate of registration, the dog shall be entered in the name shown as first choice on this form, followed by the letters N.A.F. (name applied for).

**NAMING OF DOGS (unless dog is already registered with the ISDS)**

When inserting the names of dogs on the form, please bear in mind:- Proposed names must not exceed 24 letters including affix. If you are the grantee of a registered affix and wish to use it when registering dogs (i) bred by you or (ii) bred from parents each of which was bred by you, the affix must appear as the first word in the name. Otherwise it must appear at as the last word of the name. If you are not the holder of a registered affix:- Do not use words from the dog's pedigree since they may be affixes held by another person and your proposed names will not then be acceptable. Do not repeat a word when naming puppies unless you are applying or have applied for this word to be registered as an affix (details of how to apply for an affix may be obtained from The Kennel Club). If you are submitting with this form an application to register an affix, it will be necessary for the registration of the affix to be dealt with first before the dog's registration certificate is issued. This process can take up to one month, as the application for the affix has to be advertised before it is granted. Names of notable persons, countries, cities, numerals and common single worded names are not acceptable. Also do not use single letters as part of a name, nor initials, nor your own surname.

**ENDORSEMENTS**

The registered owner of a dog may, whilst the dog is still in his physical possession, apply to have either of the following endorsements placed on the records of the dog and to have the relevant Registration and/or Transfer Certificate marked accordingly:-

- R – Progeny not eligible for registration
- X – Not eligible for the issue of an export pedigree

Please note that the two endorsements mentioned above are the only endorsements now available. Should the owner wish any of the above endorsements to be made in respect of the dog now being registered, this should be requested in a separate letter attached to the form.

Any endorsement placed in accordance with Kennel Club regulations shall only be lifted either at the written request of the individual imposing it, or by the General Committee.
