NOTES

1. This form is only to be used by the **original breeder** of a dog to request the removal of an affix or kennel name to the registered name of a dog, if it is transferred back into their registered ownership. This form cannot be used for any other purpose in terms of changing a dogs name.
2. The written acceptance of the person who placed the additional affix/kennel name **MUST** be obtained if the application is to be considered.
3. In the case of joint ownership, all parties must sign the application.
4. The name of a dog cannot be changed after 30 days have elapsed from the date of the first win which qualifies it for entry in the Kennel Club Stud Book.
5. The Kennel Club will consider a request to remove an affix/kennel name from a dog's name, but reserves the right to refuse any application.
6. If this application is successful, a revised registration certificate will be issued to the registered owner. Details of any change of name will appear in the Breed Records Supplement. However, if the application is unsuccessful, no further appeal will be considered.
7. Once an affix or kennel name has been removed, no further alterations or amendments to the name will be considered, including any future new owners adding their Affix to the dogs name
8. This application should be accompanied by any relevant Registration Certificate issued by the Kennel Club and the appropriate fee.
